# Investor request to transfer from Mercer Portfolio Service Investment Plan to CFS Edge Investments

# Request to open a new CFS Edge account

- the content of this form to be binding on me by signing below.

## Tax File Number transfer

#### I consent to:

- my currently recorded Tax File Number (TFN) to be recorded in my new CFS Edge account; and
- my TFN to be shared with related CFS entities where I, or my adviser, open additional accounts within CFS Edge where use of the TFN is authorised by taxation, personal assistance or superannuation law.
